

END-USER AGREEMENT

IMPORTANT! The Software you seek to use is made available to you only on the condition that you ("**You**") agree with Empowered Startups Ltd. ("**ES**") to the terms and conditions set forth below. **PLEASE CAREFULLY READ THE TERMS OF THIS SOFTWARE USER AGREEMENT.**

IF YOU AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT, YOU SHOULD CLICK ON THE "I Accept". IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, YOU SHOULD CLICK ON THE "I Do Not Accept".

1. **SOFTWARE:** As used in this Agreement "**Software**" shall mean the proprietary software application(s), known as YES, ESP, Empowered Nations and/or Empowered Startup Platform and all related documentation provided to You by ES or the school, incubator, or institution which provided you with your login information (the "**Company**").
2. **LICENSE TO USE:** The Company has obtained the right under license from ES to grant access the Software to certain of its students, mentees, employees, contractors, and agents solely for the purpose of providing entrepreneurship training and mentorship (the "**Purpose**"), and solely on the terms, conditions and restrictions contained in this Agreement. 3. **OWNERSHIP:** The Software and any and all knowledge, know-how and/or techniques relating to the Software, as may be modified or enhanced, in whole or in part, is and will remain the sole and absolute property of ES or its licensor (collectively the "**Owner**") and the Owner owns any and all right, title and interest in and to the Software. - (c) distribute, sell, lease, transfer, assign, trade, rent or publish the Software or any part thereof and/ or copies thereof, to others;
- (d) license or sublicense the use of the Software to others; or
- (e) use the Software or any part thereof for any purpose other than the Purpose.
